### **Information relating to the distribution in Luxembourg of the Company:**

The Company is registered with the *Commission de Surveillance du Secteur Financier (CSSF)* to publicly distribute shares in Luxembourg in accordance with the requirements of the Luxembourg law on undertakings for collective investment dated 17 December 2010, in particular its Chapter 7 relating to UCITS situated in other EU Member States which market their shares in Luxembourg.

### **Luxembourg Paying and Representative Agent**

The Company has appointed *RBC Investor Services Bank S.A.* (the "Luxembourg Paying Agent") as paying agent and representative agent of the Company in Luxembourg pursuant to a Paying and Representative Agency Agreement (the "Paying and Representation Agency Agreement") dated 12th April 2017 between the Company and the Luxembourg Paying Agent. Further to this Paying and Representation Agency Agreement, the Luxembourg Paying Agent shall act as agent of the Company for the receipt of and transmission of subscription, redemption and conversion requests and the payment of redemption and dividend monies in accordance with Luxembourg law, the Prospectus and the Articles.

The Net Asset Value per Share and subscription and redemption prices are available free of charge at the office of the Luxembourg Paying Agent and will be published on Bloomberg.

The Luxembourg Paying Agent shall upon the request of an investor provide free of charge copies of the Prospectus and of the Articles of the Company, as well as the Company's latest annual and semi-annual reports and accounts.
