Purpose

This document provides key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains, and losses of this product and to help you compare it with other products.

Comprehension Alert: You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type: The Fund is a sub-fund of GemCap Investment Funds (Ireland) plc, which is an umbrella type open-ended investment company with variable capital and segregated liability between sub-funds and is incorporated with limited liability under the laws of Ireland with registered number 485081, which was authorised by the Central Bank on 11 November 2010 as a UCITS.

As detailed in the "Switching" section of the Prospectus, Shareholders can switch between Funds and different classes within the same Fund. Subject to minimum investment and holding requirements of the relevant Class, Shareholders may convert some or all of their Shares in one Fund to Shares in another Fund or another Class in the same Fund.

The Fund is considered to be actively managed in reference to the ECB Deposit Facility Announcement Plus 3%, the Federal Funds Target Rate Mid-Point of Range plus 3% and the UK Bank of England Official Bank Rate plus 3% (the "Benchmarks") by virtue of the fact that it uses the Benchmarks for performance comparison purposes. However the Benchmarks are not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmarks.

The global fixed income securities, (which are securities that provide the Fund with a predictable income return, together with changes in its capital value) that the Fund will invest in may be fixed rate or floating rate and will be listed on one of more of the exchanges set out in Appendix A to the Company's Prospectus. The average credit quality of the Fund may be sub-investment grade (i.e. at or below S&P; rating BBB- or equivalent).

A maximum of 20% of the portfolio may be held in fixed income securities that are denominated in Emerging Market currencies. The Fund may invest up to 10 % of its net assets in aggregate in other collective investment schemes.

The Fund may use FDIs including exchange-traded futures, options and swaps) and may enter into securities lending agreements to manage credit and duration risk of the Fund. The use of derivatives will involve leverage.

Intended retail investor: The Fund is not listed on an exchange and as such is intended for investors who understand the risks of investing in private funds and are willing to assume the potential for capital loss associated with investment in such companies including the loss of the total sum invested. The minimum investment per investor is GBP1,000. We have classified this product as 3 out of 7, which is a below average risk class. The Fund has a long-term investment policy and is not intended for investors who will need access to their investment before the end of the recommended holding period of 5 years.

Maturity date: The Product has no maturity date. W1M is not entitled to terminate the Product unilaterally. The Fund may not grow to or maintain an economically viable size, in which case its directors may determine to wind up the Fund at a time that may not be opportune for investors.

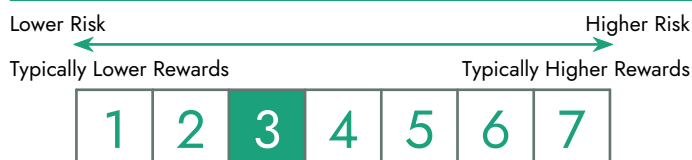

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a below average risk class.

This rates the potential losses from future performance at a below average, and poor market conditions could impact the capacity of the Fund to pay you.

What happens if the Manager is unable to pay out?

As a shareholder in the Fund, you would face a financial loss in the event of a default of the Fund. The sub-fund is not a guaranteed UCITS and as a result there is no guarantee scheme in place which provides a guaranteed rate of return.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for two different holding periods. They include potential early exit penalties. The figures assume you invest GBP 10 000. The figures are estimates and may change in the future.

How long should I hold it and can I take my money out early?

Recommended holding period: 5 years
